Both the Technical and Financial bids are to be separately sealed and put in a duly sealed bigger envelope with a mark 'Quotation for Typing and preparation of PDF (E-magazine) of College Magazine Chetna -2019-21' and should reach the college by 06.09.2021 up to 3:00 p.m. Bids received after the specified date and time shall not be considered. Technical Bids will be opened on 08.09.2021 at 11:30 a.m. in the presence of the bidders or their representatives, who may wish to be present. The financial bid will be opened on the same day at 12:30 p.m. only of those bidders, who are qualified in Technical Bid.
