This is with reference to number of queries received from Colleges/Institutions regarding the inclusion of points for Peer-Reviewed Journals in the screening and shortlisting process for the post of Principal, under direct recruitment keeping in line with the guidelines outlined in the University's Notification No. Estab.IV/047/2023 dated 20.07.2023 circulated to Colleges vide letter dated 20.11.2023.

In this regard, I have been directed to explicitly clarify that only UGC CARE list and SCOPUS publications are to be considered for screening and shortlisting of candidates for awarding points in the screening and shortlisting process for the post of Principal in Colleges. This would be applicable in the case(s) of the Colleges/Institutions in whose case advertisement for making appointment to the post of Principal has been issued on or after 01.01.2025.

Accordingly, the Colleges/Institutions, wherever the advertisement has been issued on or after 01.01.2025 onwards, necessary corrigendum be issued in spirit and a copy of the same be endorsed to the University for information. Kindly ensure that the above directives are complied with in spirit.
